With reference to the subjects cited above, as I am to inform that, REC, SU, Maddur is inviting quotation for hiring of vehicle to Maddur Mega Silk Cluster for the year 2023-24. In this connection, the details of quotation has been sent to the below enlisted vehicle provider agencies through registered post and also to the computer section for arrangement to upload the quotation in the CSRTI, Mysuru website. This office is to hire a vehicle for conducting extension activities in "Maddur Mega Silk Cluster" development programme activities (includes existing clusters of CPP, Bidarakote, Toresettahalli, Bevuru, Gajanuru and D. Halasahalli) and Evaluation of CRC/Grainage under Central Seed Act in Kanakapura Kasaba, also the district head quarter of Mandya and Ramanagara/Kanakapura, under CSR&TI, Mysore, CSB, Govt. of India, on monthly basis with the following terms and conditions.

Terms & conditions for hiring of vehicle

1. The Hiring of vehicle is on monthly basis.
2. Total number of days vehicle is required in a month - 20 days.
3. Monthly minimum usages will be 3000 Kilometer or 300 hours of duty whichever is applicable.
4. If usages extends as specified above, the excess duration shall be paid on hourly basis.
5. Monthly rate quoted shall be all inclusive including driver's bata, Toll fee, taxes etc.
6. The vehicles hired shall not be older than 5-8 years and should **have yellow board** also in good running conditions.
7. In case of break down, the vehicle shall be replaced in less than 24 hours at the cost of the service provider or will be adjusted on monthly rental of the vehicle.
8. The authority reserves the right t to terminate the contract if the services are not satisfactory and hampers the official work.

9. The hired vehicle shall run from the Head Quarter of the cluster and movement of the vehicle restricted to only cluster area.
10. The vehicle and the driver should have valid documents such as Aadhaar card/PAN, Driver, License, RC Book, Emission Test Certificate, vehicle insurance etc.,
11. The Competent Authority will finalize on hiring of vehicle.
12. Quotation should be sent by Registered Post/Speed Post only.
13. The Vehicle Provider should have PAN number registered under CGST & SGST, TDS (Tax Deduction at Source) will be effected at the time of payment under the rule 194-c of TDS rate chart.
14. After issuing the vehicle approval, Agreement to be made up to March 2024 with vehicle provider to provide the vehicle for the agreement period only. If discontinued to provide vehicle, the penal charges to be framed against the vehicle provider @ 10%.
15. The undersigned reserves the right to reject in part or in full any quotation which will not comply with the terms and conditions.
