3	The hotel shall provide lunch and dinner and the rates for the same may be quoted separately. The Hotel shall provide packed lunch to the trainees at the training institute.
4	Hotel shall provide transport to the trainees daily from Hotel to CSRTI, Mysore and back. The rates for this may be quoted separately.


